- 04. TIN / TAN number Certificate (Its Mandatory if you are dealing in international packages).
- 05. Company Registration Certificate
- 06. Address Proof (Recent Electricity Bill / Rent Agreement) from where you operate the business.
- 07. Owner / Proprietor Aadhar Card or Company Pan Card & Passport Scan Copies.
- 08. Professional Tax Registration.
- 09. Nidhi Registration (Not Mandatory)
- 10. Any Tourism Board Registration Certificate (Not Mandatory)

Fees for Active Membership B2C: Rs.2500/- Per Year (Paid by Company Account)

FOR THIS MEMBERSHIP APPROVAL FROM CWC IS MANDETORY

Benefits of Active Membership

- 01. Active Member will get a badge with membership number and logo of ETPA Association (Member is required to keep it visible to the customer at the office of his organization at all times)
- 02. After obtaining "Active" membership, the association will issue a membership certificate every year, which will be valid from 1st April of that year to 31st March of the following year.
- 03. This membership will be the first preference in the programs/excursions/seminars/seminars/exhibitions organized or organized by the association.
- 04. "Active" member shall have the right to join the Zonal Head / Central Working Committee / Board of Directors election process of the Association. Only 1 vote of individual owner / partner / director / representative in the decision making process of that organization will be valid in the decision making process.

"Active" Membership: Responsibilities and Procedures:

01. It will be compulsory for the members who have completed the membership process to attend 12 general meetings

(meetings) in every financial year

02. It will be mandatory to assist the Board of Directors in the affairs of the Association by actively participating in any

election process of the Association

03. Strict adherence to the "Code of Conduct" of the Association shall be mandatory for "Active" members.

04. "Active" members of the Association shall not be allowed to speak/complain to any person/organization outside the

Association about the private affairs/matters of the Association or face suspension and legal action if time permits.

05. "Active" member cannot cheat with his customer, if the member is found guilty before the board of directors of the association, then the membership of such member will be frozen, the minimum limit will be from 3 months to 3 years. The

member will not get his membership fee back

06. "Active" member cannot cheat with his customer / vendor / supplier / DMC, if the member is found guilty before the

board of directors of the association, the membership of such member will be suspended for a minimum period of 3 months to 3 years. If the member is due to face time, the member will not get his/her membership fee back. If the nature

of cheating is serious, suspension may also be taken.
