2. Company Registration Certificate
3. Passport Size Photo & 02 Office Photo ( External + Internal with Staff )
4. Address Proof
5. Owner / Proprietor PASSPORT SCAN COPY
6. Tax Registration Certificate
7. **Tourism Board Registration + Approved Association Registration / Approval Certificate. (Mandatory Document)**
8. **GST & MSME Certificate**

## NOTE:

1. **ETPA Admin will visit the premises personally and only after that the #PAVerified Membership will get approved.**
2. **#PAVerified members , is it mandatory to sponsor + Participate in ETPA – Paryatan Aadhar's Road Show / Exhibitions / Training Session or any Promotional Activity or Gathering at Least Once in a year**

Fees for Registration Charges as B2B: **Rs.5,000/-**

#PAVerified Membership B2B: **Rs.5,000/-** Apply For EACH YEAR for **DOMESTIC #PAVerified** Membership

## **B2B #PAVERIFIED Membership : Benefits**

01. Member will get a badge with membership number and logo of Travel Agents Association (Member must keep it visible to the customer at the office of his organization at all times)
02. After getting associate membership, **B2B #PAVERIFIED** membership certificate will be issued by the association every year, the validity of this certificate will be from 1st April of that year to 31st March of the following year.
03. Membership shall be for participation in events/excursions/seminars/exhibitions organized or organized by the Association.

04. **B2B #PAVERIFIED** The member will be allowed to advertise his organization through social media of the association, though this service is free, the date, time, day for such advertisement will be fixed by the Board of Directors by taking a resolution in the meeting.

At least 4 times in a financial year, the association is doing the work of providing online presentation slots from the association, and if such a member wants to have a real discussion or conference in the active member area, the association is making sure to provide all kinds of help in addition to the financial support.

#### **B2B #PAVERIFIED Membership : Responsibilities and Procedures**

01. It will be compulsory for the members who have completed the membership process to attend at least 1 general meeting (meetings) in every financial year

02. Associate members shall be bound to strictly follow the "**Code of Conduct**" of the Association.

03. An associate member of the association shall not be allowed to speak/complain to any person/organization outside the association about the private matters/matters of the association or shall face suspension and legal action in case of delay.

04. Associate members cannot cheat their customers, if the member is found guilty , the board of directors of the association, then the membership of such a member will be frozen for a minimum period of 3 months to 3 years.

05. **B2B #PAVERIFIED** member cannot cheat with his B2C, if the member is found guilty before the board of directors of the association, then the membership of such a member will be frozen. The minimum limit will be from 3 months to 3 years. If so, the member will not get his membership fee back. If the nature of cheating is serious, suspension may also be taken.
