**Who can apply for this membership?**

## **Provisional Membership**

Applicable for – **Only B2C**

Eligibility – **You are eligible for this membership if you are operating in B2C and providing any travel / tourism related service.**

Document Submission Time Span: Submit **SELF SIGNED SCANED PHOTO COPIES** of all below documents within **365 Days** or from the date of submitting application form submit at Pune Office: **ETPA – Paryatan Aadhar, Omkar, 49/A Senadatta Peth, Anant Kanhere Path, Pune – 411030**

**Mandatory Documents (To be submitted within 8 days of submitting application form)**

- 1. Brief of your Business & Working Areas on letter head**
- 2. Company Registration**
- 3. Proof of Current Account (Cancel Cheque)**
- 4. Visiting Card / Business Card**
- 5. Owner / Proprietor Aadhar Card**

**Other Documents (To be submitted within 365 Days from the date of submitting application form)**

- 1. GST Certificate all three pages**
- 2. MSME Certificate with mentioned GST Number**
- 3. TIN / TAN number Certificate (Its Mandatory if you are dealing in international packages)**

### **NOTE:**

§ Extension of another 365 days will be given to provisional member if for any reason he/she is not able to provide documents mentioned above.

§ This Membership will be permanently discontinued if documents are not submitted within 2 years of registration.

§ B2B supplier cannot apply for this membership as it is mandatory for them to have all the documentation completed at the time of application.

**Fees for Provisional Membership B2C is Rs.3500/- For Each Year ( Must Paid by Company Account / Company Cheque )**

### **NOTE :**

- 1. This Membership will Permanently Discontinued if documents will not submitted in 2 years of period.**

2. **This Membership is for Only One Person from One Entity , if the Partnership firm or Private Limited Firm taken the membership then apart from the Signing Entity Extra Person want to take the advantage of the benefits in the Association then charges per person Rs.3000/- must be paid Extra for that Extra Person Each Year.**
3. **I will be 100% Honest with my client and Suppliers , DRC decision will be accepted by me , they have the rights to terminate my membership the member that the customers will not be cheated by the wholesalers on stamp paper, and also in this affidavit the member must give an assurance that he will Complete the Necessary Paperwork work to become an active member as soon as possible.**
4. **A written recommendation letter from at least two active members of the association is required on the company letterhead of those members**

#### **"ETPA Provisional Membership" : Benefits**

1. A sign bearing the logo of the Ethical Travel Professional Association will be provided to the member , along with the Provisional Membership Number & ETPA certificate (the member must keep it visible to the customer at the office or organization at all times)
- 2." Provisional Member ", will be invited to places such as Events / excursions / seminars / exhibitions / Roadshows/Training Sessions & Study Tours organized by or affiliated with the association.
3. "Provisional membership" member will be allowed to advertise (B2C) his organization on social media of the association, though this service is free. the date, time, day and approval for such advertisement will be decided by the board of directors in a meeting.
- 4."Provisional membership" will be given to the members by the association by organizing some special programs on information on destination, taxation, business advertisement, tourism business regulations.
5. Arrangements have been made to invite the association to the members who have got "Provisional membership" in Tourism Board (Corporation) / and other tourism related programs.

#### **"ETPA Provisional Membership" : Responsibilities and Procedures**

01. It will be mandatory for the members who have completed the membership process to attend 9 general meetings (meetings) in every financial year
02. It will be mandatory to assist the Board of Directors in the affairs of the Association by actively participating in any working process of the Association, completing the tasks assigned by the Board of Directors and the Central Working Committee and reporting the same in time.
03. Strict adherence to the Association's "Code of Conduct" shall be binding on the "Provisional Membership" members.
04. A "provisional membership" member of the association shall not be allowed to speak/complain to any person/organization outside the association about the private affairs/matters of the association or shall face suspension and legal action in due course.
05. "Provisional membership" member cannot cheat with his customer, if the member is found guilty before the board of directors of the association, then the membership of such member will be frozen, the minimum limit will be from 6 months to 5 years. Membership fees are non-refundable

**06.** "Provisional membership" member cannot cheat with his Vendor / Supplier / DMC, if the member is found guilty before the board of directors of the association, the membership of such member will be frozen for a minimum period of 6 months to 5 years. A member will not get his/her membership fee back if time passes.
